6. Description of content: This draft resolution establishes the proposal for the Annual Review of Local Areas of the Fixed Switched Telephone Service Intended for the Use of the General Public - STFC, for the year 2020.
7. Objective and rationale, including the nature of urgent problems where applicable: Quality requirements The Regulation on Local Areas for the STFC provides for the obligation to review annual local areas and local treatment concession that fulfill the criteria of urban continuity or by reasoned request from the STFC concessionaire in the local modality. The Regulatory Agenda 2019-2020 established, among Anatel's regulatory actions, the Annual Review of Local Areas of the Fixed Switched Telephone Service Intended for the Use of the General Public - STFC. Thus, the present process deals with the annual review of Local Areas of the STFC referring to the year 2020, already within the competence of the Superintendent of Planning and Regulation considering the amendments to the Regulation on Local Areas for the STFC which were introduced by the Resolution nº 728, of 1 June 2020 [2.4], that comes into force on August 3, 2020, as provided in its art. 10.
