SENASP is establishing Technical Standards for public security, in order to give due attention and technical basis to the legitimate demand for the establishment of national and international minutes, registration of price for rental and/or acquisition of services and products of interest to the States, Federal District and Municipalities, all anchored by standards that add substantial performance to the police service.
