- **6. Description of content:** The notified Technical Regulation No. 67, 14 December 2020, amends the Technical Regulation No. 22, 24 November 2005 (published on the Brazilian the Official Gazette No. 226, page 15, on 25 November 2005) ruling the labelling of packed animal origin products.
- 7. Objective and rationale, including the nature of urgent problems where applicable: Consumer information, labelling; Prevention of deceptive practices and consumer protection; Protection of human health or safety; Protection of animal or plant life or health; Quality requirements

This Technical Regulation amends the Technical Regulation No. 22, 24 November, 2005 deals with the labelling of animal origin products. Establishments that produce products of animal origin have 180 (one hundred and eighty) days, as from the date of this Normative Instruction, to adjust the labelling of their products and update the respective registers in the electronic system, according to the Ordinance 241, 22 November 2019 (Portaria MAPA no 241, de 22 de novembro de 2019) published by the Brazilian Official Gazette 230, on 28 November 2019.
