<b>6. Description of content:</b> MAPA/SDA Ordinance No. 532 opens a 90-day period for public consultation on a proposal of Ordinance establishing the Technical Regulation defining the official classification standard of soybean and its derived products, considering its identity and quality requirements, sampling, the mode of presentation and marking or labeling, in the aspects related to product classification. Objective and rationale, including the nature of urgent problems where applicable:</b>  The revision of the official standard for soybean and its products aims at improving classification, quality, sampling and labeling requirements.  The proposal brings more objectivity in the classification of soybeans, greater clarity in the concepts and procedures related to soybean production and trade.
