This Technical Regulation establishes the cellulosic materials, packaging and equipment in contact with food and provides the positive list of components and total migration tests for cellulosic materials, packaging and equipment intended to come into contact with food.

This draft Technical Regulation revokes Decree 177, March 4^{th} , 1999 ("Portaria n. 177, de 04 de março de 1999"), and Resolution RDC n. 129, May 10^{th} , 2002.

It will be granted a period of 12 (twelve) months from the date of entry into force of this Resolution for companies to promote the necessary adjustments to comply with this Technical Regulation.

This technical regulation has been harmonized in Mercosur – Draft Resolution GMC n° 01/2011 (SGT n° 3 – Technical Regulations/Food Comission/Mercosur). It is an update of Resolutions GMC n° 19/94, 12/95, 35/97, 56/97, 52/99, 20/00.
