Description of content: This resolution establishes the procedure and technical requirements for the application for temporary market authorization on an emergency basis of medicines and vaccines for Covid-19 in experimental character to tackle the national public health emergency related to the outbreak of the new coronavirus (SARS-CoV-2)
7.	Objective and rationale, including the nature of urgent problems where applicable: Protection of human health.
	Anvisa has prepared RDC No. 444/20, as well as Guide No. 42/2020, which both deal with regulating the Temporary Authorization for Emergency Use of Vaccines. Still, the National Congress enacted Provisional Measure No. 1,026/2021, adding aspects to the Brazilian legal framework, with a direct impact on the regulatory framework then in force in the country. With the imposition of the sanction of The Conversion Bill No. 1/2021, coming from the Provisional Measure, it is necessary to advance in the regulation of the matter so that there is no normative vacuum that imposes additional challenges to the confrontation of the Pandemic.
