Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced.

The need to establish the type of measure (quantity) of the indication quantitative content of certain pre-packaged goods, in a compulsory manner as well as exemptions from mandatory.

The need for internalization of Resolutions No. 38/05, No. 2/01, No. 50/00 and No. 49/93 of the Common Market Group - MERCOSUR GMC.
