6.	Description of content: Consolidation of technical regulation for blocks of concrete for masonry.
7.	Objective and rationale, including the nature of urgent problems where applicable: Quality requirements.
	Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced.
	The purpose of the regulation is to establish the conditions under which concrete blocks for masonry should be marketed, as well as the methodology for determining their effective dimension, with a view to prevention of deceptive trade practices.
