6.	Description of content: Inmetro Ordinance No. 291 consolidates Metrological Technical Regulation for dynamic measurement systems equipped with meters for quantities of liquids
7.	Objective and rationale, including the nature of urgent problems where applicable: Quality requirements.
	Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced.
	Establish the technical and metrological requirements applicable to measurement systems equipped with measuring meters used in the measurement of petroleum, its liquid derivatives, anhydrous alcohol and hydrated alcohol fuel.
