National Institute of Metrology, Quality and Technology - Inmetro, issued the Ordinance No. 302, 12 July 2021 that approves the consolidation of technical quality regulation and conformity assessment requirements for toys.

The aim of the consolidation of the regulation is to attend decree no. 10.139 of 28 November 2020.
