6. Description of content: Inmetro Ordinance No. 319 consolidates the conformity assessment requirements for centrifugal pumps
7. Objective and rationale, including the nature of urgent problems where applicable: Quality requirements. Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced. The Need to define the minimum energy efficiency levels of three-phase electric motors induction rotor squirrel cage, nationally manufacturing or imported, for commercialization or use in Brazil. Need to establish minimum performance and safety requirements for all pumps and centrifugal pumps
