<b>6. Description of content:</b> Inmetro Ordinance No. 336 consolidates the technical regulation on the quantitative indication of fresh biological yeast.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Consumer protection  Decree 10.139 of 28 November 2019 provides for the need for revision and consolidation of normative acts below the decree. It aims to update and consolidate regulatory acts, elimination of obsolete regulations whose effects have been exhausted in time or the need cannot be identified. Thus, the inventories and complexity of regulatory processes will be reduced.
