Description of content:** Ordinance No. 202, 26 January 2021, opens a 45-day period for comments on a draft of a Technical Regulation that establish the minimum requirements for premises and equipment for settlement and operation of poultry farms and for eggs and derivatives processing units.
- **7. Objective and rationale, including the nature of urgent problems where applicable:** Protection of human health or safety; Quality requirements; Protection of animal or plant life or health; Cost saving and productivity enhancement.

The proposed Technical Regulation aims to replace the Ordinance No. 01, 21 February 1990 in order to modernize the registration procedures and updating the guidelines on the minimum requirements regarding facilities and equipment related to poultry farms processing units of eggs and derivatives.
