NOTIFICATION

Addendum

The following communication, dated xx January 2017, is being circulated at the request of the delegation of the Brazil.

This addendum aims at informing that the National Institute of Metrology, Quality and Technology – Inmetro issued the Ordinance Nº 563, 29 December 2016, to approve the Technical Regulation for Toys, inserted in the Annex I of this Ordinance, previously notified under the document (G/TBT/N/BRA/597 – Ordinance Nº 310/2014) which determines the mandatory compliance requirements to be attended by every supply chain of the product in the national market, regarding the Product safety.

The objective of this Regulation is to clarify a set of existing requirements under the Toys Regulations related to the physical and mechanical properties; chemical requirements to flammability, toxicological hazards of toys; markings requirements, instructions for use; mandatory information on the product packaging, product use restrictions, etc.
