Description of content:</b> Technical regulation amending Ordinance n <sup>o</sup> 13, 30 November 2015, that established basic procedures for safety recording and marketing of additives used in products intended for animal feed in order to ensure an adequate level of protection of human health, animals and the environment, and to introduce requirements to the additives labelling, aiming at providing the minimum information for safety reasons.  It revokes letter "b" of item VII of subsection 3.2; the section "e" of item 3.5.1, section "g" of item 4.2 of Annex I and item 5 of Annex II, all of them of Ordinance 13, 30 November, 2004 (Instrução Normativa 13, de 30 de Novembro de 2004).
