6.	Description of content:
	This draft Resolution establishes criteria for packing and labelling of dental bleaching agents which are classified as medical devices.
	According to this draft technical regulation, the distribution of medical devices used in dental bleaching, containing hydrogen peroxide or carbamide peroxide with concentrations of these substances higher than 3%, alone or in combination, is subject to the dental prescription.
	Packaging and labelling of dental bleaching agents containing those substances shall include, in red stripe and emphasized, the phrase: "Sale under dental prescription". The leaflets shall include, emphasized and in a larger font, the phrase: "Sale under dental prescription."

	It's allowed the sale of the products directly to dental surgeons and legal persons that provide dental services.
