This draft Resolution updates the procedures which are necessary to the regularization of disposable personal hygiene products in Anvisa, through the simplification of processes, in order to improve the quality of the information and the agility in health surveillance measures. Disposable products regularized according to Ordinance n. 1.480/1990, Ordinance n. 97/1996, Resolution RDC n. 10/1999, Resolution RDC n. 211/2005 and Resolution RDC n. 343/2005, can be manufactured until 24 (twenty-four) months after the publication of this draft Resolution and marketed until the expiration date of the product. This draft Resolution revokes the following technical resolutions: Ordinance n. 1.480/1990, Ordinance n. 97/1996 and RDC n. 10/1999.
