This draft resolution establishes the following modifications: Inclusion: 1.1. List "C1": Benzydamine 1.2. Inclusion of the addendum 7 in the list "C1" According to this draft resolution, it is prohibited to import, manufacture, manipulate, acquire, sale and dispense systemic use BENZYDAMINE based medicines. BENZYDAMINE

based medicines which pharmaceutical forms are extemporaneous preparation powder, gynaecological solution, spray, drops, mouthwash, toothpaste and gel are not subject to special control. The establishments that use the substance BENZYDAMINE will have a period of 30 days from the date of publication of this Resolution for adaptation to the requirements of the Ordinances SVS/MS 344/98 and 6/99. However, to obtain the Special Authorization this period will be of 180 days.
7. Objective and rationale, including the nature of urgent problems where applicable: Protection of human health or safety
