<b>6. Description of content:</b> This Resolution provides for the specification and control of the quality of liquefied petroleum gases (GLP) marketed by economic agents in the national territory.  It revokes:  I - ANP Resolution No. 18, 2 September 2004;  II - Articles 9 and 10 of ANP Resolution No. 681, 5 June 2017
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b>  the main objective is to review the Liquefied Petroleum Gases (LPG) specifications, especially with regard to winter LPG and the definition of the amount of propane and butane that should be present in the mixture  This Resolution establishes the specifications of LPG showed in Table I of Annex I and the obligations regarding quality control attended by economic agents that commercialize the product in the national territory.  Applies to LPG used for industrial, residential and commercial purposes, according to current legislation, except when used as raw material in chemical and physical processes.
