6.	Description of content: MAPA Ordinance No. 240 amends the annex to MAPA Normative Instruction No. 22 of 24 November 2005, which approves the technical regulation for the labelling of packaged animal products.
7.	Objective and rationale, including the nature of urgent problems where applicable: Quality requirements
	The notified Ordinance no. 240, rules the labelling of animal origin products, replaces the Technical Regulation 67, 14 December 2020, notified as G/TBT/N/BRA/1111, that aimed to internalize the MERCOSUR/GMC resolution No. 26/03, within the Brazilian regulatory framework. The TR 67 contained statements that did not meet the originally proposed objective and therefore is revoked.
