This draft Technical Regulation revokes Annex V of Decree 177, March 4 <sup>th</sup> , 1999 (“Portaria n. 177, de 04 de março de 1999”).  It will be granted a period of 12 (twelve) months from the date of entry into force of this Resolution for companies to promote the necessary adjustments to comply with this Technical Regulation.  This technical regulation has been harmonized in Mercosur – Draft Resolution GMC n° 02/2012 (SGT n° 3 – Technical Regulations/Food Commission/Mercosur). It is an update of Resolution GMC n° 47/98.
