- **Title, number of pages and language(s) of the notified document:** Ordinance No. 169, 23 March 2015. The text proposes improvements on the requirements to assess conformity by the Road Vehicles and Equipment Manufacturers/Bodybuilders and/or vehicles transformers (20 pages, in Portuguese).

Description of content:** Conformity assessment procedures that must be met by manufacturers, bodybuilders and/or transformers of road vehicles, and vehicles equipment manufacturers, through the inspection mechanism to highlight the conformity of the vehicle or equipment established by the RT requirements in order to promote the vehicles and equipment safety, as well as user's safety.

This text applies to manufacturers of car body shell, bodybuilders and/or vehicles transformers and vehicle equipment manufacturers, with total yearly production of less than one thousand (1,000) units.
